In case of any inconsistency in tariff category or missing tariff category, the rates as approved by MERC in Case No. 195 of 2017 dated 12th September, 2018 for MSEDCL will be considered based on the tariff schedule as approved for MSEDCL for the respective financial year.

Notes:

1. Additional Fixed Charge of Rs. 185 per 10 kW load or part thereof above 10 kW load shall also be payable
2. Billing Demand for all LT categories where Demand based Tariff is applicable: Monthly Billing Demand will be the higher of the following:
 - A. 65% of the Actual Maximum Demand recorded in the month during 0600 hours to 2200 hours
 - B. 40% of the Contract Demand
3. Billing Demand for all HT categories (except HT I (B): HT - Industry Seasonal category): The Monthly Billing Demand will be the higher of the following:
 - i. Actual Maximum Demand recorded in the month during 0600 hours to 2200 hours
 - ii. 75% of the highest Billing Demand recorded during the preceding eleven months
 - iii. 50% of the Contract Demand.
