Demand/Fixed Charge and Wheeling Charge have been levied for all consumer category as per the tariff schedule as approved for MSEDCL for the respective financial year by the Hon'ble MERC in Case No. 226 of 2022 dated 31<sup>st</sup> March, 2023. There is reduction in Energy Charges for all consumer category as compared to tariff schedule as approved for MSEDCL for the respective financial year by the Hon'ble MERC in Case No. 226 of 2022 dated 31<sup>st</sup> March, 2023. In case of any missing tariff category, the rates (except Energy Charge) as approved by the Hon'ble MERC in Case No. 226 of 2022 dated 31<sup>st</sup> March, 2023 for MSEDCL will be considered for the respective financial year.

Notes:

**1. Billing Demand for all LT categories having MD based Tariff:**

Monthly Billing Demand will be the higher of the following:

- A. 65% of the Actual Maximum Demand recorded in the month during 0600 hours to 2200 hours
- B. 40% of the Contract Demand

*Note:*

- Only the Demand registered during the period 0600 to 2200 Hrs. will be considered for determination of the Billing Demand.

- In case of a change in Contract Demand, the above period will be reckoned from the month following the month in which the change in Contract Demand is effected.

**2. Billing Demand for all HT categories:**

Monthly Billing Demand will be the higher of the following:

- A. Actual Maximum Demand recorded in the month during 0600 hours to 2200 hours
- B. 75% of the highest Billing Demand recorded during the preceding eleven months, subject to the limit of Contract Demand.
- C. 75 % of the Contract Demand.

*Note:*

- Only the Demand registered during the period 0600 to 2200 Hrs. will be considered for determination of the Billing Demand.

- In case of a change in Contract Demand, the above period will be reckoned from the month following the month in which the change in Contract Demand is effected.

**3. TOD Rates-**

The ToD Tariff is applicable to the LT II (B), LT II (C), LT III (B), LT III (C), LT V (ii), LT VII (B) (ii), LT VII (B) (iii), LT VIII and , HT I (A), HT II, HT IV, HT VIII (B) and HT IX Categories and also optionally available to LT- II (A), LT V (i), LT VII (B) (i) category consumers having ToD meter installed.
