There is reduction in Energy Charges for all consumer category as compared to tariff schedule as approved for MSEDCL for the respective financial year by the Hon'ble MERC in Case No. 217 of 2024 dated 28th March, 2025 to read with Review Order in Case No. 75 of 2025 dated 25 June, 2025. In case of any missing tariff category, the rates (except Energy Charge) as approved by the Hon'ble MERC in Case No. 217 of 2024 dated 28th March, 2025 to read with Review Order in Case No. 75 of 2025 dated 25 June, 2025 for MSEDCL will be considered for the respective financial year.

Notes:

- 1. Billing Demand for all LT categories having MD based Tariff:
 - Monthly Billing Demand will be the higher of the following:
 - A. 65% of the Actual Maximum Demand recorded in the month during 0600 hours to 2200 hours
 - B. 40% of the Contract Demand

Note:

- Only the Demand registered during the period 0600 to 2200 Hrs. will be considered for determination of the Billing Demand.
- In case of a change in Contract Demand, the above period will be reckoned from the month following the month in which the change in Contract Demand is effected.
- 2. Billing Demand for all HT categories:

Monthly Billing Demand will be the higher of the following:

- Actual Maximum Demand recorded in the month during 0600 hours to 2200 hours
- 8. 75% of the highest Billing Demand recorded during the preceding eleven months, subject to the limit of Contract Demand.
- c. 75 % of the Contract Demand.

Note:

- Only the Demand registered during the period 0600 to 2200 Hrs. will be considered for determination of the Billing Demand.
- In case of a change in Contract Demand, the above period will be reckoned from the month following the month in which the change in Contract Demand is effected.

As per 7.13.63 and 7.13.96 of MERC order in Case No. 217 of 2024 dated 28th March, 2025 considering the implementation time for modification of ToD Slabs for existing consumers with ToD meters, the Commission has allowed transition period upto three months for HT consumers and upto six months for LT consumers. As per 7.13.97 and 7.13.98, the Applicable ToD Tariff (Charge/Rebate) for existing ToD consumers during transition period are as per below.

Above ToD tariff will be applicable to the existing ToD consumer till ToD tariff slots are updated in consumers' meters. Once the meter replacement or modification is completed, consumers will be transitioned to the revised ToD Tariff structure.
