Under Rule 45 of the Indian Electricity Rules, 1956, no electrical installation work including additions, alterations, repair and adjustment to an existing installation except such replacement of lamp, fans, fuse, switches, low voltage domestic appliances and fittings in no way alter its capacity or character, shall be carried out upon the premises of or on behalf of any consumer, owner or occupier except by an electrical contractor licensed in this behalf by the State Government and under the direct supervision of a person holding a certificate of competency and by a person holding a permit issued or recognized by the State Government.

8. Declaration:

I / We hereby agree:

- a) To pay the Charges for Shifting of Meter / Service (as per MERC approved Schedule of Charges).
- b) To pay the amount to be incurred towards the shifting of Services as per the cost estimate, which will be given by TUCO.
- c) To be bound by MERC (Electricity Supply Code and other Conditions of Supply) Regulations, 2005 as amended from time to time and to provide the necessary security deposit as specified therein.
- d) To pay for the said supply at the prevailing tariff rates and also to pay the charges based on Schedule of Charges as approved by MERC for TUCO from time to time.
- e) Permissions for carrying out excavation etc. within consumer premises shall be obtained by the Consumer from the Housing Society Industrial Estate / Commercial Complex. All excavation (including obtaining necessary local municipal body permit) and back filling required for cable laying / diversion etc. upto the consumer premises will be carried out by TUCO.
- f) To undertake removal of excess earth if any and permanent reinstatement of the surface at your cost.
- g) To provide suitable earth pit, in case of shifting or meter panel.
- h) To provide suitable weather protection roof for the same in case the Meter panel is mounted on wall outside the building.
