I/we have read the Maharashtra Electricity Regulatory Commission (Electricity Supply Code and Standard of Performance of Distribution Licensees including Power Quality) Regulations -2021, and amended from time to time, agree to abide by the conditions mentioned there in and to provide necessary security deposit as specified therein.
3. I/We will deposit electricity dues, every month, as per the applicable electricity tariff and other charges.
4. I/we will own the responsibility of security and safety of the meter, cutout and the installations thereafter.
5. I/we have complied with all requirements under all statute for the time being in force and shall be held legally responsible for any issue arising out of any such non-compliance. The Distribution Licensee is indemnified from any loss that may occur on account of such noncompliance.
6. I/We will be bound by the provisions of the Power Supply Agreement (for all sanctioned load of 50 KW/63 kVA and more) & Substation Space Agreement (where substation is required) to be executed with TUCO.
7. That there are no arrears pending against the premises for which I/we have applied for power supply. If any arrears are found to be pending against the said premises, I/we shall be bound to make payment towards such arrears. Also, I/we have been informed and made aware that if any previous arrears are pending on the premises, I/we shall not receive any new connection for the said premises.
8. I/we am/are the sole occupant/owner of the above premises for which the above mentioned meters are connected and that the electric supply from the above connection is used exclusively for the above premises. I also state that I am not receiving supply at the above premises through any other meter/meters.
9. In case of any false representation on my/our part or case of any objection from the present registered consumer or in case the documents produced by me/us are not absolutely correct, TUCO reserves the right to transfer the connection from the name of the present registered consumer.
10. I also under take to keep TUCO indemnified of any consequences at any time in future in case of any dispute on account of the transfer of the above connection to my/our/name/names.
11. That the following terms and conditions shall be complied with, for applicant/consumer's installation beyond the point of supply of TUCO:
 - a. The Applicant / Consumer must install appropriately rate MCB with enclosure near the start of the electricity supply and shall not install DP Switch.
 - b. The Applicant / Consumer, if having voltage exceeding 250 Volts, shall provide his own earthing system for installation.(including shifting of meter panel.)
 - c. The Applicant / Consumer, if having sanctioned load above 2 KW, shall install Earth Leakage protective device. (Kindly review a,b,c)
12. The excess earth if any and permanent reinstatement of the surface at consumers cost within consumers premises.
13. To uprate the cable and related equipment's after the point of supply to appropriate size to match with the enhanced capacity (for load extension/reduction/category change/meter shifting)

12. The excess earth if any and permanent reinstatement of the surface at consumers cost within consumers premises.
13. To uprate the cable and related equipment's after the point of supply to appropriate size to match with the enhanced capacity (for load extension/reduction/category change/meter shifting)
14. In case the Applicant is not the sole owner of the premises, no objection certificate for seeking electricity connection from the co-owner has been obtained.
15. The internal wiring at the premises has been tested by a Licensed Electrical Contractor and the test certificate is available with the applicant and can be produced as may be required at any later stage.
16. The premises/building structure has been constructed as per prevalent building Bye-laws and the total height of the building
 - i) Does not exceed 15 (fifteen) meters of the date of seeking service connection; or
 - ii) Is more than 15 (fifteen) meters and has obtained Electrical Inspector clearance (High Rise Certificate) under Central Electricity Authority (Measures relating to Safety and Electric Supply) Regulation, 2010 clause 36 (1) is available with the applicant.
17. There is a provision of lift in premise and the applicant has obtained the lift fitness certificate from the Electrical Inspector for the lift in the said premises and same is available with the applicant.(kindly review)
18. Applicant submit necessary occupancy certificate i.e. certified copy of plan, CC, OC, repair permission issued by the appropriate authority to TUCO
19. The above referred applicable documents/certificates indicated at various points are available with Applicant and can be inspected by the Licensee at any time. In case of any failure to produce the same, the TUCO may disconnect the connection granted owing to such failure, reluctance on my part to produce/allow the inspection of said documents/certificates.
20. Applicant is solely and exclusively responsible for the genuineness and

correctness of the document/s submitted by him in support of the application and the other documents as indicated at various points herein. In case any such documents are found to be fraudulent and / or fake and/or forged and/or incorrect and /or invalid/incomplete, then the applicant/consumer shall be solely and exclusively responsible for the criminal proceedings and/or any court proceedings initiated and/or any dispute which arises any time in future and TUCO and/or its successors, assignees and/or any employee thereof, shall not be responsible for the same in any manner whatsoever. In such a case, TUCO reserves the right to disconnect the connection granted under this declaration cum undertaking, without any notice.

21. All details mentioned in the application form are correct and all applicable customer-end obligations (E.g. Documentary and Payment compliance, Site readiness, Way-Leave permits) are complete and complied in all respects, at the time of applying for new electricity connection, through online / offline mode. In case any of these requirements are not ready, or in case of an objection, TUCO reserves the right to cancel the application.
22. Applicant industry /trade has not been declared to be releasing obnoxious hazardous/pollutant by any government agency and that no orders of any court of judicial authority would be breached by running of Applicant industry /trade or granting any electricity connection to the same. The TUCO is indemnified against any loss accrued by the applicant on this account.
23. Applicant indemnify TUCO against all proceedings, claims, demands, costs, damages, expenses that TUCO may incur by reason of a fresh electricity connection given to the Applicant.
24. The Applicant further agrees to indemnify and hold harmless, TUCO and/or its successors and/or its employees, in case of any injury or incident on account of any fault in electricity work in the premises and from point of supply to the Premises. The TUCO shall not be held responsible/ liable for any mishap or incident occurring at the premises or from point of supply to the Premises to the applicant on account of any faulty/defective/ inferior quality wiring /installation, right from the time of energizing the new electricity connection. On occurrence of such incident, TUCO may disconnect the Applicant's supply, if continuance of supply to such installation is threat to the life or property. Such disconnected supply shall be reconnected only after rectification of faulty installation and submission of test.
25. The Applicant further agrees to bear the expenses towards repairing/replacement of TUCO's assets or works, in case :
 - (i) There is sufficient proof that the damage/ fault has been occurred due to faulty electrical work/ wiring in his premises and
 - (ii) Applicant is unable to provide valid test reports for his installation
26. To pay the electricity consumption bills and all other charges at the rates set out in the TUCO Licensee's Tariff Schedule and MERC approved scheduled of charges for supply as may be in force from time to time, regularly as and when the same becomes due for payment.
27. To deposit the additional security deposit and additional service line cum development (SLD) charges, if any from time to time based on the prevailing Orders/rules, directions and Regulations of the Commission.
28. That TUCO shall be at liberty to adjust the electricity consumption charges due/outstanding along with any other charge against the Consumer Security Deposit paid by the Applicant, in the event of termination of the agreement prior to expiry of the contracted period or in case of any contractual default as per provisions of regulations/rules/orders/directions of the Commission.
29. The Applicant/Consumer shall identify suitable space agreeable to TUCO to install electrical meter and related devices and ensure unhindered passage to personnel of TUCO to access the meter cabin. To allow clear and un-encumbered access the meters for the purpose of meter reading and it's checking etc.
30. The following terms and conditions are complied with respect to space for meter installation:
 - a. Metering installation is protected from excessive dust and moisture, exposure to direct sunlight, rain and water seepage and vermin. The Applicant / Consumer shall ensure that temperature within the meter room shall not be more than 10°C, above ambient. It should not be in proximity of machineries, heating devices, equipment generating high vibration or magnetic fields and areas prone to fire and toxic hazards.
 - b. Meters are not located at an elevated area or a depressed area that does not have access by means of a stairway of normal rise. The meters shall not be installed below/in the stair case or in common passage or lobby.

31. For GSTIN : As per Rule 49 of CGST Rules, 2017, a Bill of supply (monthly electricity bill) shall print Goods and Services Tax Identification Number or Unique Identity Number, if registered, of the consumer For PAN:

i) As per Rule 114B of Income Tax Rules 1962 every person is required to quote his PAN in all documents pertaining to the transaction of sale or purchase of any nature for a value exceeding Rs. 2 lacs per transaction for the purpose of clause (c) of sub-section (5) of Section 139A

ii) As per section - 206AA of Income-tax Act, 1961, TDS (if applicable) @20% on Security Deposit Interest will be deducted instead of 10% for non-availability of valid PAN.

32. The applicant/consumer shall provide way leave in favour of TUCC:

i) To lay its cables through his / owner's land/ property

ii) To access TUCC's equipment and work in its premises in accordance with the applicable provisions of Supply Code or any other Regulations, as prevailing from time to time

iii) To provide permanent Right of Way to TUCC personnel along with vehicles and cables and/or apparatus, without any further consent (for now and in future)

iv) For laying, strengthening and maintaining of electrical network and system

v) for laying outgoing feeders (LT/ HT) from their premises as the same arrangement is for making interconnection with outside network which shall further help in arranging alternate supply in case of break down on mains. In the event land under way leave permission is sold, leased, rented or otherwise disposed off, while entering to such a transaction the applicant/consumer shall ensure by necessary covenants that these terms and conditions will be abided by the other parties to the said transaction.

33. The excavated trenches shall be reinstated by the Applicant/Consumer at his/her own cost when the cable is laid to provide supply to their premises. TUCC shall be responsible to reinstate in the event the works is carried out to provide supply to any other customer.

34. TUCC shall have full rights to optimally utilize its assets (Substation/pillars) in applicant / consumer's premises and shall not object to laying outgoing feeders (LT/ HT) from their premises as the same arrangement is for making interconnection with outside network which shall further help in arranging alternate supply in case of break down on mains.

35. Applicant has installed or shall install an Earth Leakage Circuit Breaker device (ELCB)/MCB for single phase connection & 4 pole

MCCB/ELCB/RCCB for three phase connection of appropriate size before using power supply service at Applicant aforesaid premises where electricity connection has been sought. Applicant too declare that, earthing is done at applied premise and equal load is distributed on all phases. On Applicant failure to install the said devices), Applicant shall be solely held responsible for any miss-happening, safety breach/ incident due to negligence etc. at the aforesaid premise. TUCC shall be free to proceed with the cancellation of electricity connection and disconnection etc.

36. Applicant would let the Licensee disconnect the service connection under reference, in the event of any default, non-compliance of statutory provisions and in the event of a legally binding directive by Statutory Authority (ies) to effect such an order. This shall be without prejudice to any other right of the TUCC including that of getting its payment as on the date of disconnection.

37. Applicable only for applied load between 100kW and 150 kW, The Applicant authorizes TUCC to debit the approved connection charges and applicable security amount in first electricity bill (as and when enabled by TUCC) and undertake to pay the same within the due date. The Applicant/Consumer may opt to pay such Security Deposit by way of Bank Guarantee.

38. Applicant shall not hold TUCC liable for delay in providing connection or meeting any Standards of Performance subsequent to grant of connection in case TUCC is prevented from doing so on account of any force majeure events / exemptions as specified in the Standards of Performance Regulations, as amended from time to time.

39. The contents herein above are true and correct and confirmed by me with free will without any coercion or force, in full conscious and not under any influence of intoxication. I further affirm that I have not given any false information or withheld any information to mislead TUCC or provide any false or forged documentary proofs. In case of any false representation on my part or in case of any objection from the present registered consumer or in case the documents produced by me are not absolutely correct or found to be false, The TUCC reserves the right to take appropriate actions (including reverting the address to existing address as mentioned at the time of address correction/ re- transferring the connection in the name of present registered consumer(s)). I hereby indemnify and keep the TUCC indemnified forever against the losses, damages, adverse claims, litigation or any other liability financial or otherwise which TUCC is subjected to by reason of any dispute, difference, litigation etc. on account of the transfer of the above connection to my name/address correction, based on my request, for the above consumer number.
